- 1. Rathton Road grant funding update
- 2. Advertisement of ordinance amendment for yard sales. Ordinance will allow for two yard sale events per calendar year of not more than 3 consecutive days. The existing ordinance allows for a yard sale event of not more than two consecutive days.
- 3. Advertisement and a public hearing for the following zoning amendments: §310-12.C fences, §310-12.E(9)- Home Occupation, §310-12.G(4) & (5)-Family day-care homes, and 310-13(H)- Garage and yard sales. The purpose of the amendment is to establish for fencing height and setback provisions for recreation courts. The other amendments provide clarification for family childcare home uses and permits for yard sales.
- 4. Green Light Go Richland Avenue/Country Club Road Preliminary Concepts and Alternatives
  Four intersection improvement alternatives. Per staff Option 3 (concrete island with divisor and a left turn
  phase on the traffic signal for east bound traffic on County Club Road) may be the best selection for remedying
  the issue of east-bound traffic movement.
- 5. **Regional Law Enforcement.** Status: Department of Community and Economic Development has been commissioned to prepare a police management, and staffing and department assessment study.

#### New Business

- 1. Resolution 2023- YAUFR 2024 Budget. The 2024 total budget is \$9.6M which is a 7% increase from the 2023 budget. Spring Garden Township's budget allocation for 2024 is \$2.13M (a 2% increase from 2023). The draft budget needs to be approved by Manchester, Springettsbury, and Spring Garden Townships.
- 2. Resolution 2023- Act 600 member contributions to Police Pension Plan
- 3. Ratify the 2024 Uniform and NonUniform Minimum Municipal Obligation (MMO). The MMO is the Commonwealth of Pennsylvania mandated smallest amount a municipality must contribute to any pension plan established for its employees. The amount is calculated using actuarial science to ensure that municipal pension plans are sufficiently funded. Uniform (police officers) MMO with contributions \$395,959 and Nonuniform (public works and administration) \$137,622.53
- 4. Resolution 2023- Police Policies. The policies update the General Orders for use of force, transportation of prisoners, & traffic accident investigation
- 5. Renew MAXxess (door access) Software Support (3 yr.) \$150/yr.
