## SPRING GARDEN TOWNSHIP CIVIL SERVICE COMMISSION MEETING MINUTES OF JANUARY 2, 2024

Meeting minutes of the Civil Service Commission held Monday, January 2, 2024, and attended by Commissioners Kenya Brown-Feeser, Robert Lehman, Aaron Hall, Alt-Commissioner Thomas Warman, and Chief George Swartz.

Chairman Feeser-Brown called the meeting to order at 4:10 P.M.

Minutes of the September 26, 2023, civil service meeting were reviewed and upon motion by Commissioner Lehman and a second by Commissioner Brown-Feeser and by unanimous vote the meeting minutes were approved. Commissioner Hall abstained from the vote.

Upon motion by Commissioner Lehman and second by Commissioner Brown-Feeser and by unanimous vote the Civil Service Commission elected Commissioner Hall to the position of Vice-Chairperson. Commissioner Hall abstained from the vote.

Upon a motion by Commissioner Hall and second by Commissioner Brown-Feeser and by unanimous vote the Civil Service Commission elected Commissioner Lehman to the position of Secretary. Commissioner Lehman abstained from the vote.
