HOMESTEAD REBATE: It is not necessary for you to reapply for the Homestead rebate every year. The Homestead rebate only applies to the school tax.

DOG LAW

Many residents of Spring Garden Township own dogs. Along with the benefits of owning or keeping dogs are responsibilities. This article serves as a reminder of some basic dog law here within our Township and across the Commonwealth.

Cases are regularly filed at District Court 19-2-05 for violations of local township ordinances pertaining to dogs running at large and barking dogs. L.O. § § 110-2, 110-5. There are limitations against excessive noise from barking after 10:00 p.m. until 6:00 a.m. and against continual daylight barking. Cases are also filed at District Court 19-2-05 for violations of state statutory law pertaining to failure to license, failure to vaccinate, failure to confine and dangerous dogs. 3 P.S. § § 455.8, 459-101 et seq.



Violations of dog law may result in a citation being filed by our township animal control officers, township police officers or a state dog warden. Except in the case of a dangerous dog citation, a citizen receiving a citation can choose to plead guilty or not guilty (in which case

a summary trial is scheduled). Persons who plead guilty or are found guilty will have to pay a fine, costs associated with involvement of animal control officers and court costs. A citizen receiving a dangerous dog citation <u>must</u> appear for a summary trial. Jennifer J.P. Clancy, Esq. Magisterial District Judge District Court 19-2-05 1410 Sixth Avenue York, PA 17403

The dangerous dog case is especially difficult because it involves a family pet that has allegedly bitten and injured or even killed another animal or human.

The judge has to make a decision as to whether a defendant is guilty or not guilty



of harboring a dangerous dog. In the case of a subsequent state dog law violation within one year of sentencing for the prior violation a criminal charge may be filed. A citizen receiving such a charge would be required to attend a preliminary hearing

To all those who are owners or keepers of a dog within Spring Garden Township, enjoy your pet but care for your pet responsibly.

United States Census 2020

The census is a count of every person in the United States and its territories; the US started the census in 1790 to count the entire population, and a new census is held every 10 years. Your response to the census is mandated by the U.S. Constitution. Your responses also help direct more than \$675 billion to communities nationwide. Some programs funded by census information include: community support, family services, education, food assistance, employment, healthcare, entrepreneurship, infrastructure, environment, and public safety.

You will receive a notice in early 2020 to complete the census online, by phone, or by mail. In May, the US Census Bureau will begin following up in person with households that did not respond.

You will be asked: age, sex, and the number of people in your home, including children

You won't be asked: for a social security number, bank or credit card numbers, money or donations, or anything relating to political parties

Is my Information Safe?

Your responses are safe, secure, and protected by federal law. Your answers can only be used to produce statistics. They cannot be used against you by any government agency or court in any way—not by the FBI, not by the CIA, not by the DHS, and not by ICE.

Let's Send a Strong Message to the Criminal Element

Do you own a surveillance camera that records footage?

When a crime takes place in a public area, we often spend a lot of time going door to door to see if residents / business owners have security cameras and asking them if they would allow us to review the footage. With the **Camera Registration Program**, we can save time by reaching out to our residents / business owners that we already know have cameras and are willing to help-potentially aiding in the apprehension of the suspect(s) responsible for the crime being investigated. Participation in the program is completely voluntary.

The process for registering your camera is simple and takes only a few minutes. You will be asked to provide basic information regarding your camera. The registration form can be found by going to the Spring Garden Township Police Department's website at <u>www.sgtpd.org</u>. Once on the website, go to the "Forms Tab" and then to the "Camera Registration Form".

Turn your camera into a crime-fighting tool and lets' send a strong message to the criminal element that the Spring Garden Community and Police Department are working together as a team to keep our community safe.

Thefts

Many of our reported thefts continue to be from vehicles that were left unlocked. We would remind our residents to remove valuables from your vehicle and ensure that the windows are up, and the doors are locked when parking your vehicle.





Zoning and Building

Property Improvements

The Township appreciates when you make improvements to your property, however, please call the Township Administration Office before starting your project to check if a permit is required.

Pool Information

Pools (inflatable, temporary, and permanent) capable of holding 24 inches or more of water requires a Spring Garden Township Building Permit to ensure compliance with the 2009 International Residential Building Code.

Temporary pools collapsed and stored away at the end of summer will <u>require an additional permit</u> every year when the pool is set-up.

Building Permit vs Zoning Permit – Which is Needed?

Did you know that a **building permit** is needed for sheds, detached garages, and carports over 1,000 sq. ft. in size, an attached garage, additions to your home or business, fences over 6-feet in height, roof framing replacement, roofs over a patio or porch, enclosing a porch, decks 30 inches above grade, pools (temporary, permanent, inflatable) capable of holding 24 inches of water, new or replacement doors or windows (call for more details), all commercial/industrial remodeling/renovations, and conversions/change in use and occupancy. A Building Permit is needed for any work requiring an inspection under the state building code (Uniform Construction Code).

A **Zoning Permit** is needed for most other improvements which typically do not require building inspections but do require compliance with the Township Zoning Ordinance such as: sheds, detached garages, and unattached carports less than 1,000 sq.ft. in size; fences – up to 6' high; retaining walls – up to 4' high; sidewalks and curbing; walkways and driveways; patio or porch with no roof or walls; deck – not more than 30 inches above grade; temporary business promotion signs; residential outdoor firepit area – also needs review and approval by the Fire Department (York Area United Fire & Rescue)

What is needed to complete a Building/Zoning Permit Application?



• Property address



- Property owner's name and contact information
- Contractor's information and workers compensation insurance information
- A complete description of the work
- A site plan is also required showing lot size and dimensions, dimensions of structures and paving, setbacks, and elevation sketches (if applicable.)

Fees: Payment of fees is NOT required up-front. Fees are collected after plan reviews are completed and prior to issuance of the permit.

- Zoning Permit fee is \$25.00
- Building Permit fees are based at \$7.00 per \$1,000 (or fraction thereof) for the cost of the construction **plus** plan review, inspection, administration and state permit fees as calculated by CCIS (Commonwealth Code Inspection Service), our third-party agency who will be reviewing and approving the plans.

Codes Enforcement

Large Item Pickup & Garbage / Recycling Collection Site

Penn Waste offers Spring Garden Township residential customers the opportunity to dispose of large or oversized items that do not fit in a traditional waste receptacle.

Spring Garden Township residents are permitted one large item per week on the second day of collection. This counts as one garbage bag or one garbage can. Large items may be set at the collection site the evening before the second day of collection. Large and oversized items must be able to be lifted into the truck by two people. Loose piles will not be collected/disposed. If more than one item is placed at the collection site. the additional item(s) will not be collected and must be removed from the collection site.



Garbage and recycling containers cannot be placed at the collection site earlier than 6:00 p.m. on the evening preceding the scheduled collection day.

Empty garbage and recycling containers must be removed from the collection site within 12 hours from the time the collection is made.

Neighbor to Neighbor

Do you have a situation where bushes and trees between you and your neighbor extend over the property line? The township recommends you first talk to your neighbor about the problem because your neighbor may not be aware there is a problem. If after speaking with your neighbor about the concern and there is not a resolution, seek legal counsel. Your legal counsel can provide very important guidance.

Residential Rental Properties

The 2020 residential rental unit applications were mailed December 2019. Remit the completed application and fee of \$145 for each residential rental unit to Spring Garden Township

by January 31, 2020. Bi-annual inspections will be scheduled following receipt of the completed application and license fee.

If your residential rental unit was not inspected during 2019, please contact Spring Garden Township to schedule the bi-annual inspection.

Tenant Change?

Submit the completed Tenant Change Application and \$80 inspection fee to the Township. Following receipt of the completed Tenant Change Application and fee, a New Tenant Inspection will be scheduled. The inspection is to be done prior to the new tenant moving into the residential rental unit.

Grass and Weeds

The Township receives many complaints each growing season about properties not cutting weeds and grass. The Township Ordinance states that a property is to be maintained free from weeds and plant growth in excess of 6 inches. It is essential to keep your lawn mowed, the weeds pulled, and your flowerbeds tidy. Please do not blow grass clippings in the street.

For Dog Owners

No one likes offensive smells! When your dog has a bowel movement, please pick up and properly dispose of the dog waste. Also, it is important to make sure your outside dog play area is free and clear from doggie waste. To eliminate the odor of urine outside, sprinkle lime over the area, then douse the lime with water.



2020 Dog licenses available at the York County Treasurer's Office. State law requires all dogs 3 months or older to be licensed by January 1.

Yard Waste Drop-Off & Collections

Yard Waste Drop-Off

Spring Garden will open <u>1799 Mt. Rose Avenue</u> to help with yard waste disposal. Please follow the drop-off area signs when entering the site.

Details: Yard Waste drop-off service will begin on the first Saturday in March from 8:00am - 12:00pm. Yard waste collection ends after the first Saturday in November 2020. Public Works staff will be on site to assist with unloading.

This service is offered to Township residents and appropriate ID confirming residency is required. This service is not intended for independent contractors retained to perform homeowner projects for Township residents.

<u>Accepting</u>: tree limbs less than 8 feet in length and less than 8 inches in diameter. Limit drop-offs to two truck or trailer loads.



Yard Waste Pick-Up Service by Penn Waste

Penn Waste will offer yard waste pick up service. There is no bag limit for these special collection days.

Details: pick up for yard waste will occur the fourth Saturday of each month from April through October. Items must be on the curb before 7am on the scheduled collection day.

Accepting: yard waste material such as tree-trimmings, shrubbery, and any other organic landscape vegetation. Bags must be biodegradable paper (found at Lowes, Ace, Home Depot, and Walmart), and bundles must be tied with twine. Bundles may be no longer than 4 feet, and branches must be less than 6 inches in diameter. No bundle may weigh more than 30 lbs.

Not Accepting: grass clippings, food waste, leaf waste, dirt, and stones.

Yard Waste Between Collections

H&H General Excavation Company, 660 Old Hanover Rd., will take branches and brush for their mulching operation. Call 717-225-4669 for more information.

Details: Open 7 days/week during daylight, free of charge.

Accepting: Branches and brush for mulching.

Not Accepting: treated wood, grass, weeds, dirt, food, other yard waste, and stones.

A reminder for property owners: sidewalks and curbs should be kept in good condition. If you receive a letter stating you need to do repairs, you will have 60 days to do the emergency work.



Think Before You Wash!

Spring Garden Township is a Municipal Separate Storm Sewer System (MS4) municipality and preservation of the environment is an important topic today. Consider your car - is handwashing the best method?

The "greenest" method to wash a car is by using an automatic car wash. Studies show roughly half the amount of water is used when compared to a traditional car wash with bucket and hose. Regulations also require car washes to clean their wastewater, which can sometimes be reused.

Car washing impacts creeks and streams because waste water carries soap residue, oil, acid, and other metal particles into storm drains, and eventually to our waterways. If you plan to wash by hand, please use cleaners that are biodegradable and non-toxic. Also, please wash your car on grass or gravel to prevent waste water from making it to storm drains and eventually waterways.

PUBLIC WORKS DEPARTMENT

SEWER BACKUPS: If you have a problem with a sewer backup between the hours of 8:00 a.m. and 4:00 p.m., please call the Township Administration Office at 717-848-2858, and ALSO CALL YOUR PLUMBER. We will try to have someone from our sewer department meet the plumber on site. After normal business hours, please call 9-1-1 and they will contact someone from the Township to respond to you.

SEWER WORK

- To all residents: If you have sewer clean out caps keep them exposed. If you break the cap, call the office. We will replace it.
- 2. Sump pumps are not to be pumped into the sewer system. We pay by the gallon to York City and Springettsbury Township.
- 3. Also, keep your fresh air vent opened for your sewer to breathe.

Inflow and Infiltration (I & I): Residents should not put stormwater into the sewer systems, or have sump pumps going into the sewer, down-spouts, or floor drains; these should all go into the grass, or into a pit with fabric and stones – the pit should be sized to hold the proper amount of runoff.

FACTS

Some people assume baby wipes, sanitary napkins, and other household items are gone forever, once they have been flushed. The truth is they're not. Items such as these, after time, turn into a grayish pulp that can wrap around a pump. Each occurrence requires a two-person crew two hours to accomplish. Often crews are called out after hours to clear the pipes. These are additional costs that impact all customers.

DISPOSAL TIPS

A lot of products have a recommended method of disposal listed right on the package. If you are ever unsure if an item is safe to dispose of in the drain or toilet call us 717-848-2858 or just throw it in the garbage can.

Many car centers or garages in the area will take your used motor oil. Contact your local garage or car center and ask them if they recycle the used motor oil and any instructions on how to prepare it and when to bring it to them.

Repair leaky plumbing fixtures. A leaky toilet can waste up to 2,000 gallons of water in a single day.

OUTSIDE THE HOME

DON'T dig without knowing the location of your sewer system.

DON'T connect rain gutters, storm drains, or sump pumps to the sewer system.

DON'T dump RV waste into your sewer collection system. Take it to an authorized RV dump site.

Call PA One Call before you dig.



TOWNSHIP COMPLIANCE WITH MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT (PAG-13) FOR DISCHARGES FROM SMALL MS4s

Spring Garden Township is the owner of a municipal separate storm sewer system (MS4) that discharges to surface waters of the Commonwealth of Pennsylvania. Therefore, the Pennsylvania Department of Environmental Protection (PA-DEP) requires that the Township obtain and comply with the requirements of a NPDES General Permit (PAP-13).

In June 2018, Spring Garden Township submitted a MS4 Annual Report Form which outlined the Township's efforts to comply with the NPDES GP-13 requirements from April 1, 2014 through March 31, 2015. The Township follows the PA-DEP's 6 Minimum Control Measure (MCMs) protocols which include:

- Public Education and Outreach of Storm Water Impacts
- Public Involvement/Participation
- Illicit Discharge Detection and Elimination
- Construction Site Storm Water Runoff Control
- Post-Construction Storm Water Management in New Development and Redevelopment
- Pollution Prevention/ Good Housekeeping for Municipal Operations

Examples of Illicit Discharge

Anything other than water leaching or leaking into open or closed storm water sewers or storm water drainage systems is considered an <u>illicit</u><u>discharge</u>. This includes illegal connections or tie-ins to existing storm sewers. It also includes disposal of sewage and septage, washwater flows or graywater from homes and businesses, liquid wastes, tap water flows, landscape irrigation, cleaning agents, and other harmful chemicals.





Don't let a good drop go bad!

THE PROBLEM

Do you ever think about what happens to a drop of rain that falls onto the ground? It may land on a tree and evaporate; it may land on a farm field and be absorbed into the soil; or it may land on a rooftop, driveway or road and travel down the street into a stream or storm drain. Any precipitation in an urban or suburban area that does not evaporate or soak into the ground, but instead pools and travels downhill is considered stormwater. Stormwater is also referred to as urban stormwater runoff and polluted runoff. Increased development across York County's watersheds has made stormwater runoff the fastest growing source of pollution to the creeks, river, and the Bay

THE SOLUTION

Urban stormwater Best Management Practices are designed to prevent sediments and other pollutants from running off the land during and after construction. They include:

- Adopting and implementing stormwater management ordinances that control both the quantity and quality of stormwater runoff;
- Adopting open space policies that encourage natural vegetated areas and minimize impervious areas such as parking lots, streets and roads;
- Adopting riparian stream buffer ordinances that encourage vegetated and forested buffer areas along streams and other water bodies;
- Using structural and vegetative practices during construction such as sediment basins, silt fencing and temporary gravel construction entrances;

- Using post-construction BMPs such as detention basins, constructed wetlands, grassed waterways, sand filters, retention ponds, municipal street sweeping, storm sewer inlet filters, and oil/grit separators; and
- Implementing good housekeeping practices at home and work such as proper lawn care, the use of lowphosphate detergents, and the proper disposal of household chemicals.

The Township has adopted and enforces a Stormwater Management Ordinance. All stormwater management plans are required to have engineering review and approval before approval of all new developments.



Spring Garden Township and the York County Conservation District have a Memorandum of Understanding (MOU) for review and enforcement of erosions and sediment control measures. **If you think you have observed an erosion or sediment problem from any construction site, please call 717-841-7430, the York County Conservation District.** The District will investigate these issues for the Township and enforce the regulations as applicable.

If you have any other type of stormwater problem or concern, please call the Township Office at 717-848-2858 to have it investigated. You will be required to provide your name, address, telephone number where you can be contacted, along with the specific location and description of the problem.

TRASH/RECYCLING

2020 RESIDENTIAL TRASH AND COLLECTIONS

The regular trash collection schedules remain the same with the exception of holiday pickups and additional Yard Waste pickups. Please read below for the 2020 information.

WARD 2, WARD 3, AND WARD 4 (WEST OF S. QUEEN ST.)

TRASH: Up to four 32 gallon size bags/cans, picked up on Monday and Thursday.

RECYCLING: Scheduled pick up on Monday.

One large item: Picked up on Thursday.

WARD 1, WARD 3, AND WARD 5 (EAST OF S. QUEEN ST.)

TRASH: Up to four 32-gallon size bags/cans, picked up on Tuesday and Friday. **RECYCLING:** Scheduled pick up on Tuesday. **One large item:** Picked up on Friday.

Filled containers may be placed at the curbside/ collection site after 6:00 p.m. on the evening prior to scheduled collection days. As a reminder, all empty containers must be removed from the curbside/ collection site within 12 hours from the time the collection is made. Containers or items that do not comply with regulations and were not collected connot remain at the curbside/collection site between scheduled pick-ups.

<u>NEVER</u> place plastic bags in your recycling bins.

When you place plastic bags in your recycle bin, they can get wrapped around our sorting equipment, then Penn Waste team members at our recycle center have to climb into the machinery and cut off the plastic bags.

RECYCLING TOTES

Recycling totes are provided to the residents of Spring Garden Township by Penn Waste, Inc. It is recommended that you put your address on the tote with a permanent ink marker. Please call Penn Waste at 717-767-4456 with any questions.

LARGE AND OVERSIZED ITEM PICKUP

Penn Waste offers Spring Garden Township residential customers the opportunity to dispose of large or oversized items that do not fit in a traditional waste receptacle.

Spring Garden Township residents are permitted one large item per week on the second day of collection. This counts as one garbage bag or one garbage can. Large items may be set at the collection site the evening before the second day of collection. Large and oversized items must be able to be lifted into the truck by two people. Loose piles will not be collected/disposed. If more than one item is placed at the collection site, the additional item(s) will not be collected and must be removed from the collection site.

ACCEPTABLE ITEMS LARGE ITEMS

- Appliances (including refrigerators, washing machines, stoves, dishwashers); please call Penn Waste for guidelines and details
- Carpet (48" maximum length, rolled, and tied)
- Furniture
- Mattresses and box springs (Must be a matching set)
- Car tires (TIRES ONLY. Must be removed from the rims)
- Scrap metal

NON-ACCEPTABLE ITEMS

- Stains, chemicals, and liquids
- Automobile parts
- Household hazardous waste
- Construction materials or debris, including:
 - * Drywall * Block
- * Treated Lumber
- * Roofing
- * Shingles
- * Ceiling Tiles
- * Concrete

* Brick

TRASH/RECYCLING

RECYCLE USED MOTOR OIL

Pour all collected used motor oil into a clean, empty sealable container such as plastic milk jugs. Specialized used oil containers can be purchased at local auto parts stores. Do not mix used motor oil with any other substances, such as antifreeze, paint or other chemicals. It is a good idea to call ahead to confirm the hours of operation and to be sure that the site still accepts used oil. At the collection site, ask an attendant where to deposit used oil. Don't leave your container of used oil at the site if unattended. Take your empty container home with you to use again. The following retail establishments will accept used motor oil for recycling:

HELP ELIMINATE LITTER AND ILLEGAL DUMPSITES

Spring Garden Township residents can help our community celebrate Earth Day every day of the year. Residents, organizations, civic groups, schools, and neighborhoods that want to clean up litter or eliminate illegal dumpsites, can dispose of waste from a clean-up effort free of charge at the York County Resource Recovery Center. The Authority is working with Keep York County Beautiful to stop illegal dumping in our community and clean up existing dumpsites. Keep York County Beautiful will assist with providing free gloves, bags and safety vests. WHAT TO DO WITH MEDICAL NEEDLES

If you take shots at home for a medical condition and must dispose of needles, we recommend that they be placed in a glass or very heavy plastic bottle with a secure cap and put in the trash. If you are a small medical office or dental office that uses a residential trash pick-up service **you are required** to dispose of needles and other medical waste through a medical and infectious waste removal company.





DISPOSAL OF PAINT AND PAINT CANS

You may dispose of oil/latex liquid paint in the regular trash. If there is wet paint in the cans, pour it out on old newspaper and let it dry. Dispose of the newspaper in the regular trash. Another way to dry up paint in old cans is to add either oil dry or cat litter to the container. This must then be placed in the regular trash. Empty paint cans may be recycled. Empty spray paint cans are recyclable also. Full paint cans cannot be recycled. If you must place a can with wet paint in the trash, please make sure the lid is on tight and secured and in a heavy plastic bag so that it does not break open and splatter paint on the trash hauler, the street, a car or property nearby.

DISPOSAL OF COOKING OILS

Cooking oils, shortenings, and cooking grease should not be washed down the drain! These materials can clog and block sewer lines. The correct way to dispose of cooking oils, is to place them in a secure can or suitable container with a lid. It's okay to place recycling cans or bottles in the trash if they are being used to dispose oils or grease.

DISPOSAL OF COMPACT FLUORESCENT LIGHT BULBS

Although Spring Garden Township has no outlet for recycling these bulbs, we would like to inform our residents that you may take these bulbs to the York Home Depot or Lowes for recycling. Also, Sylvania provides consumers with pre-labeled recycling kits to recycle small and large quantities of CFL's and other light bulbs. You may find further information on their web site at www.sylvania.com/recycle.



RECYCLING ENFORCEMENT FOR LARGE COMMERCIAL ESTABLISHMENTS, INSTITUTIONS, AND GOVERNMENT BUILDINGS

All establishments are required by State and Local laws to be in compliance with recycling requirements (this applies to all offices, restaurants, grocery stores, retail shops, service shops, schools, hospitals, churches, civic groups, banks, and any other establishment that does not fit into the residential category.) Due to the larger volume of waste, more than four 32-gallon size containers, you must privately contract for disposal of your waste and recycling. **You are required to separate your recycling from your waste!**

Items required to be recycled are:

- Corrugated cardboard
- High-grade office paper (including white computer paper, copier paper, letterhead, manila file folders, and similar white office paper. Please note that shredded paper must still be recycled.
- Aluminum, steel, and bimetallic cans
- Glass (clear and colored)

Note: Incineration of materials is not recycling! The mandated items listed above must be "recycled" in a manner so the material can be used again for making new products. **If you are not already recycling, you must make arrangements with a recycling hauler!** No business or residence is too small. Items cannot be taken out of the township for recycling. Most times, the company you're paying to collect your trash can provide a way to collect your recycle.

All establishments must report each year! In the last quarter of every year, Spring Garden Township will mail each business/establishment or institution a report that MUST BE COMPLETED and returned to the Township. The report asks you to fill out your information, identify the types of materials recycled at your location and the name(s) of your private contractor(s). We will then contact these haulers and ask them to supply us with amount of materials you recycled. If they are unwilling to provide this data directly to us, we will contact you, and it will become your responsibility to obtain the data and report it to us.

Fines and penalties for violations of our recycling ordinance is established for those who do not recycle or fail to report to the Township. Fines range from \$25 up to \$600 plus costs and, in default of payment of said fine and costs, result in a term of imprisonment not to exceed 30 days per violation. Each day that a violation continues or each violation constitutes a separate offense.

BASIC RESIDENTIAL GUIDELINES

- No more than four (4) trash cans/bags will be collected each week unless using an Extra Service Bag.
- Extra Service Bags are available at the Township Office for \$5.00 each.
- Bags or containers must not exceed 32 gallons or 50 pounds.
- Bulk items that are too heavy to be lifted into a truck by two people will not be accepted.
- Call Penn Waste to schedule collection of appliances containing freon (air conditioners, refrigerators, freezers, etc.)
- No construction debris will be collected curb side.
